



**LAKEWOOD BOYS RUGBY CLUB  
PARENTAL PERMISSION, WITH WAIVER & RELEASE**

1. The player and his parent(s) and/or legal guardian(s) (together referred to as the "undersigned"), hereby consent to player's participation with the Lakewood Boys Rugby Club (the "team"). The player and undersigned understand and agree that participation includes but is not limited to, practice sessions, games, meetings, functions, fundraisers and the like.
2. In consideration of the opportunity afforded to the player to play rugby, the undersigned hereby release, discharge and covenant not to sue USA Rugby, the Midwest Rugby Union, the Ohio Rugby Union, the Northern Ohio Rugby League (the "league") and each of the school teams which are members of the league as well as any sponsors of any of these entities from all actions, damages, claims and demands, whether legal or equitable of every kind and character. We release the team, its coaches, trainers, volunteers and sponsors, and the officers, administrators and directors of any liability which may arise from the player's participation in team activities and in the sport of rugby.
3. The undersigned further understand that the team may provide transportation alternatives as an accommodation. Such transportation will usually be via private automobile and/or buses, coaches or mini-vans. Drivers may include other parents, guardians, coaches or other properly licensed players. The undersigned waive any and all claims against any and all such drivers.
4. The undersigned understand and agree that the team is not sponsored by Lakewood High School or the Lakewood School District, and consequently these institutions and their administrators and officials are not responsible or liable for injury, sickness, disability, paralysis or death that may result from player's participation with the team and all claims against said entities and individuals are waived.
5. The undersigned understand that rugby is an exciting, rough, physical contact sport and as with all contact sports, the possibility of injury, be it serious or minor, always exists. The undersigned hereby accept and assume the risks that accompany participation. The undersigned agree they will not hold the team, its coaches, volunteers, administrators, sponsors, members and officials responsible for injury, sickness, disability, paralysis or death that may result from participation with the team and all such claims arising from such participation are waived.
6. The undersigned understand that there is not always a medical physician or trainer at the team's games and practice sessions.
7. The undersigned agree to ensure the following:  
The player has a physical to determine that they are medically able to play rugby.  
The player has appropriate medical insurance.  
The player has a mouth/gum guard.  
The player avoids the use of alcohol, tobacco and/or controlled substances without proper prescription.  
The player keeps his/her life clean and in accordance with laws and regulations.  
The player will help/participate at fundraisers organized for the benefit of the team.

**The undersigned agrees that this release is binding and effective as to themselves as well as to their personal representatives, assigns, heirs and next of kin and that it applies to any and all loss or damage claimed on account of injury, disability or death, whether caused by the negligence of the above referred to entities, organizations or individuals or otherwise.**

The undersigned understand by signing this release they are giving up their rights they would otherwise have to recover for losses, damages, illnesses, injury, disability or even death. They agree they are doing so voluntarily and without inducement, threat or duress. The undersigned agree they have had opportunity to seek legal advice before signing this release and have either done so or voluntarily elected not to and waive this opportunity.  
We have read and understood the preceding statements of the scope of the relationship and of the responsibilities among the several parties identified above and specifically agree to it all, including the waiver and release of liability set forth above.
